#### I. CONTRACT INFORMATION

This Change Order is made in regards to contract **NMHC 2024-001**. The contract is between the Northern Marianas Housing Corporation, referred to herein as "NMHC," and Paragon Corporation dba Coreplus Construction, referred to herein as the "Contractor."

### II. REQUEST FOR EXTENSION

The Contractor has requested a no-cost modification of the original contract to extend the period of performance. The NMHC has reviewed the Contractor's request and determined that the need for an extension of time is reasonable. The extension is due to delays that is beyond the contractor's control. Moreover, the extension is not the result of the contractor's inexperience, inefficiency, or incompetence. Finally, the NMHC has determined that an extension of the period of performance is in the best interests of the NMHC.
